I have attempted to make this as clear and concise as possible whilst keeping to Music Partnership and Musicians Union guidelines. - **Encouragement to practice** Regular practice is essential if a pupil is to make progress. Parents can support their child in this, for example, by:
 - -showing interest in what they are learning
 - -encouraging regular daily practice (at least ten minutes on five days each week)
 - -providing a suitable space for the practice to be done
 - -checking that the instrument and music are taken to school on the day of the lesson
 - -providing extra encouragement when progress is slower because of particular problems
 - -checking and signing practice diaries regularly
- **Music Centre Opportunities** The instrumental teacher may, when appropriate, suggest that your child might like to join the local Music Centre where opportunities are available to play with others of a similar standard in bands and orchestras. Experience shows that young players gain an enormous amount from these activities, and that their progress is enhanced considerably.
- **Buying an instrument for your child**The Music Partnership wishes to encourage pupils to buy their own instruments wherever possible. Advice will be given by the teacher, and a number of options are available.
- **Borrowing an instrument** It is sometimes (but not always) possible for a pupil to borrow an instrument through the Music Partnership. Parents may be responsible for any repairs to the instrument which arise as the result of lack of care. Repairs should not be undertaken without permission from the instrumental teacher. The one off fee of £30 for instrument loan is non-refundable and your child can keep the instrument as long as having lessons from the teacher who ordered the instrument.
- **Timetabling arrangements** The teacher will aim to provide at least 10 lessons each term. The exact number will depend on the availability of the teacher and on the length of an individual term.
- Invoicing arrangements The lesson fees will remain the same for the whole of the academic year. An invoice for the appropriate half-termly fees will be sent home with your child at the commencement of lessons. It is the parents responsibility to check for these invoices. It has been found that pupils taking them home is more reliable than the postal service! If the payment date is not met, then lessons will be discontinued or a late payment fee applied- but the lessons received will remain payable.

It is suggested that payments are placed in the instrument case on the day of an instrumental lesson.

On a letter at the start of each academic year, and on invoice reminder slips, the payment due dates are provided for your reference.

- **Discontinuing instrumental lessons** It is inevitable that some pupils may decide after a period that they do not wish to continue receiving instrumental tuition. Where a decision is made to discontinue lesson, notice must be given two weeks before the end of a half term. If lessons are ceased mid term then the invoice for that term remain payable.
- **Problems and Questions** Please contact the instrumental teacher, (by email for the quickest response) who will be pleased to discuss anything regarding lessons or your child's progress. Should you provide an email address above, your teacher will email just to welcome your child to lessons and open a channel of communication that can be invaluable in helping your child gain the most from instrumental lessons.
